## **Summary:**

The main news event of the month was publication of the CJC costs review. We were the first organisation to issue comment but, somewhat surprisingly, the story did not receive the amount of coverage one might have expected and so take-up was limited.

Separately, BLC has been lobbying *The Times* for some years to feature a wider range of legal careers in its periodic student supplement and this finally bore fruit with a request for a case study of a young Costs Lawyer. We profiled Amy Dunkley and the reporter at *The Times* was pleased with what we produced; however, its inclusion has been put back to the next student supplement in around three months' time.

As detailed below, we have also had a request for content from Partners in Costs for their magazine. This originated in conversations with Adrian Hawley at the Manchester conference.
