Summary:

March has been a particularly productive month with three press releases drafted, one was distributed resulting in coverage (David Heath, see coverage below) and a further two will be distributed during April. Our regular articles also appeared in *Solicitors Journal* and *Thomson Reuters Dispute Resolution Blog.*

Following our presentation at Council, we have been in contact with *Legal 500* re: the potential of listing Costs Lawyers, and have been invited to submit a proposal.
