Summary:

An active month working across ACL and ACLT with two comments sent out on behalf of ACL and a press release for ACLT on apprenticeships to coincide with National Apprenticeships Week. Coverage was achieved for all these stories with 11 pieces achieved in February.

Separate meetings were held with Council and ACLT, with activities arising from both meetings, most notably to progress a judicial roundtable for ACL and a career focused roundtable for ACLT.
